

1. The total cost of the Trinity Inner Cor Academy Yoga Training Course (the Course) is \$7595.00 (inclusive of GST) payable by four instalments as follows:

Deposit: \$900.00 payable within seven (7) days of receipt of formal acceptance of Application. (Not refundable)

Second Instalment: \$2,232.00 payable by 18<sup>th</sup> June 2010

Third Instalment: \$2,232.00 payable by 17<sup>th</sup> September 2010

Fourth Instalment: \$2, 2231.00 payable by 10<sup>th</sup> December 2010

Once the documents have been signed the participant is liable for all course fees. Fees are not transferable, nor refundable. If the applicant withdraws from the Academy there will be no refund unless the Academy deems fit.

The Instalments are payable by way of Cash, Cheque or via Credit Card (3% bank charges apply) payments.

2. The duration of the Course is a minimum of one (1) year and up to two (2) years. (A minimum of 350 hours.)

3. The Course is fully accredited by the Yoga Teachers Association of Australia ("YTAA").

4. Lecture notes will be supplied, where appropriate.

5. Students must provide their own equipment.

6. Upon satisfactory completion of the Course, all Students will be eligible to apply for the full membership of YTAA.

7. Upon formal acceptance of this Application and payment of the Deposit, the Applicant acknowledges that no payments of Deposit or further Instalments are refundable, except within the absolute discretion of the Academy.

8. Successful completion of the Course will be adjudicated by way of completion of the full Course structure together with satisfactory

assessment of practical and theoretical Course materials, as determined by the Academy.

9. Students will only be entitled to receive a Certificate of Completion upon successful completion of the Course.

10. All students must attend a minimum of ninety percent (90%) of set class time.

11. Whilst not mandatory, it is recommended that Students wear appropriate yoga apparel or ICY Yoga Wear to classes at all times. The Academy reserves the right to determine appropriate apparel.

12. All course papers, documents, videos, tapes, DVDs and other materials are the sole property of the Academy at all times and must remain confidential and not be copied, reproduced, disseminated or distributed in any way whatsoever and any person found to have inappropriately used the course papers, documents, videos, tapes, DVDs or other course materials for copying, reproducing, disseminating or distributing purposes without the express written consent of the Academy will be liable for any and all loss occasioned by such inappropriate use or costs associated with enforcing the Academy's proprietary rights therein.

13. The Academy, its agents and representatives make no representations or warranties with respect to future employment prospects for successful Students upon completion of the Course.

14. The Applicant hereby acknowledges that he/she has agreed to participate in the Course and its associated activities of his/her free will and desire. The Applicant undertakes the Course on the distinct understanding that he/she does so voluntarily and at his/her own risk.
